Recent Good News

- Seven off-shore wind farm projects have been expedited as part of the government's aim to increase significantly renewable energy generation over the next ten years.
- Ireland has recently moved to 12th place in the EY Renewable Energy Country Attractiveness Index (RECAI). For the first time since 2016, the United States leads the index.
- In response to the current crisis, the
 Department of Arts, Heritage and the Gaeltacht
 has published information on the supports
 available to the <u>arts sector</u>. Included in a new
 booklet are application details for a number of
 financial and other initiatives, to assist those
 working in culture and the arts.
- This week the Government announced that Technological University (TU) status has been awarded to the TU Consortium made up of the Institute of Technology Tralee, and the Cork Institute of Technology. The new <u>Munster</u> <u>Technological University</u> (MTU) will be officially established on 1 January 2021, becoming the second TU in Ireland, the first outside Dublin.
- Dublin Zoo and its partner in sustainability, Airtricity, have launched the <u>Eco Explorers Club</u>. This exciting development is a new digital resource to help inspire and educate young children on the wonders of the natural world.
- Non-EEA nationals who have entered Ireland but have not yet attended their first registration appointment, can now apply by email to request a letter confirming their permission to remain in the country. This letter will act as an Irish residence permit card.

Intellectual Humility and Intelligence

A recent <u>BBC Reel video</u> examines the importance of intellectual humility, i.e. understanding and admitting when we might get things wrong. It seems that people are becoming more convinced of their own beliefs and less willing to consider other viewpoints. The presenters argue that this is detrimental to intelligence, and that having intellectual humility could actually make us smarter.
